

What you need to know about your will

WHY SHOULD YOU CREATE A WILL?

A will is simply a way of formalizing your choices and your desires. Nearly 60% of Canadians do not have a valid will and do not realize how important they are. No matter the size of your estate, having a will is simply good stewardship.

If you die without a will, your assets are distributed according to provincial laws, and you have no control over the distribution. When you choose not to create a will, you give away any choices about all you leave behind and place additional burdens on your loved ones.

With planning and the guidance of financial experts, you can ensure more of your money goes where you want it to, and less is removed from your estate through taxation. Advisors with Purpose is happy to make referrals if you require additional legal advice.

Leaving a gift for general purposes to Compassion is as easy as choosing to include a statement like one of these when you create or update your will:

- I direct my Trustees to pay as soon as possible after my death, the sum of XXX Thousand Dollars (\$X,000.00) to Compassion Canada, 985 Adelaide St. S., London Ontario N6E 4A3, for its general purposes (or for a designated purpose).
- I direct my Trustees to divide XX% of the residue of my estate to Compassion Canada, 985 Adelaide St. S., London Ontario N6E 4A3, for its general purposes (or for a designated purpose).

You can be assured that all donations given to general purposes will go to help children in areas of greatest need.

LIVING SPONSORSHIPS

Many of our sponsors wonder what would happen if they died before their sponsored children completed the Compassion program. To make sure that the child you sponsor is supported until their graduation, you could choose to include one of the following statements in your will:

- I direct my Trustees to pay as soon as possible after my death, the sum of XXX Thousand Dollars (\$X,000.00) to Compassion Canada, 985 Adelaide St. S., London Ontario N6E 4A3 to use the said funds to continue the sponsorship of any Compassion child or children that I was sponsoring at the time of my death, for as long as Compassion in its discretion considers it advisable. If I am not sponsoring a child at my death, it may be used for Compassion's general purpose.
- To divide XX% of the residue of my estate to Compassion Canada, 985 Adelaide St. S., London Ontario N6E 4A3 to use the said funds to continue the sponsorship of any Compassion child or children that I was sponsoring at the time of my death, for as long as Compassion in its discretion considers it advisable. Any remainder is to be used for Compassion's general purposes.

ALEX AND JUDY ARE LEAVING A LASTING LEGACY

For over three decades, Alex and Judy have been positively impacting the lives of children and their families living in poverty. They desire that their impact lives on even after God calls them



home. Alex shared, "Several years ago, we revised our wills to include a percentage of any estate we may leave to go to Compassion. Compassion's financial credibility assures us that our funds will be used in a way that honours God.

"As part of our living legacy, we have chosen to sponsor as many children as we can in order to see them progress now and enjoy seeing them advance towards a better future. This has been a blessing as we have watched several of our sponsored children graduate and move on into successful lives. Their graduations have opened doors for us to continue to sponsor other children who need an opportunity to be freed from poverty in Jesus' name.

"For us, we have the joy of seeing a living legacy now, through the lives of those we have sponsored, the lives of those we currently sponsor and the promise of that portion of our estate being placed into the hands of Compassion so the legacy will continue according to God's plan. You may choose to leave a legacy that will be initiated after your life on earth is completed or you may choose to leave that legacy now while you can enjoy watching it change lives as it releases children from poverty in Jesus' name. Either way, it is an eternal investment yielding the greatest returns."



Ways you can make a lasting impact

WILLS

Include Compassion Canada as a beneficiary in your will. All it takes is a simple statement such as those provided under 'What you need to know about wills'. This choice will lessen the future financial tax burden on your family.

GIFT OF RRSP/RRIF

For many Canadians, the largest tax liability at death comes from RRSP/RRIF holdings. Unless your spouse is the beneficiary of your RRSP/RRIF, the full value counts as income in the year of death. This means that a RRIF worth \$100,000 can generate a tax bill of up to \$46,000! Donating some or all of your registered account to charity reduces or eliminates the tax payable, allowing your estate to have a greater impact.

LIFE INSURANCE

You can name Compassion Canada as the beneficiary of a new or existing life insurance policy, which can include group insurance plans. Your estate will receive a charitable donation receipt for the full death benefit.

GIFTS OF SECURITIES

If you donate publicly traded securities (stocks, bonds, mutual funds or segregated funds) to Compassion Canada and those securities have increased in value, the gift is not subject to capital gains taxes, as long as you transfer the shares in kind from your broker to ours.

HOW WILL MY GIFT BE USED?

You may specify in your will where your gift is to be used or you may let our Legacy Giving team know the area closest to your heart. If your chosen designation is not feasible when your estate is being settled, you can be assured that Compassion will direct your donation with integrity to where it's most needed to release children from poverty in Jesus' name.

CAN I ENSURE MY COMPASSION CHILD HAS AN OPPORTUNITY TO GRADUATE?

Yes! What a wonderful gift to remind the child you sponsor that you planned for their care just like you do for your own family. We can help you set up support for your child after you have passed until he/she graduates or leaves the program. If your child exits the program prior to the planned completion date, the remainder of your gift will be directed to support Compassion's programs where there is the greatest need. Alternatively, you may let the Legacy Giving team know where funds should be directed.
